  - (i) Number of beds of HCF: 50
  - (ii) Number of health care facilities covered by CBMWTF: NA
  - (iii) Installed treatment and disposal capacity: NA
  - (iv) Area or distance covered by CBMWTF: NA
  - (v) Quantity of Biomedical waste handled, treated or disposed: Yellow- 3.7 Kg/day, Red- 0.9 Kg/day, White- 0.9 Kg/day, Blue- 4.5 Kg/day
4. This authorisation shall be in force for a period of 03 Years from the date of issue.
  - 4.1 The authorization shall be valid for till 26/01/2026
5. This authorisation is subject to the conditions stated below and to such other conditions as may be specified in the rules for the time being in force under the Environment (Protection) Act, 1986

**Terms and Conditions of Authorisation**

1. The authorisation shall comply with the provisions of the Environment (Protection) Act, 1986 and the rules made there under.
2. The authorisation or its renewal shall be produced for inspection at the request of an officer authorised by the prescribed authority.
3. The person authorized shall not rent, lend, sell, transfer or otherwise transport the biomedical wastes without obtaining prior permission of the prescribed authority.
4. Any unauthorised change in personnel, equipment or working conditions as mentioned in the application by the person authorised shall constitute a breach of his authorisation.
5. It is the duty of the authorised person to take prior permission of the prescribed authority to close down the facility and such other terms and conditions may be stipulated by the prescribed authority.
6. The Unit will file the renewal application at least 2 months prior to the expiry of this Order

**Specific Conditions:**

1. HCF shall obtain consent to operate from Board within 01 month, failing which this authorization shall be deemed void.
2. The Authorization or its renewal shall be produced for inspection at the request of an officer, Authorized by the prescribed authority.
3. The Authorized person shall not rent, lend, transfer or otherwise transport the bio-Medical waste without obtaining prior permission of the prescribed authority.
4. It is duty of the Authorized person to take prior permission of the Board to close down the facility and such other terms and conditions may be stipulated by the prescribed authority.
5. Any unauthorized change in personnel, equipment or working condition as mentioned in the application by the person authorized shall constitute a breach of this authorization.
6. Bio- Medical waste shall not be mixed with other waste.
7. Bio- Medical waste shall be segregated into containers/ bags at the point of generation in accordance with schedule I. Prior to its storage, transportation, treatment and disposal. The Containers shall be labelled according to schedule IV.
8. No untreated bio medical waste shall be kept stored beyond a period of 48 hours.
9. You shall submit an annual report to the U.P. Pollution Control Board in from IV by 31st January every year. And include information about the categories and quantities of Bio Medical waste during the preceding year.
10. You shall maintain record related to the generation, collection, reception storage, Transportation, treatment and disposal and / or any form of handling of Bio Medical Waste in accordance with rule and guidelines, all records shall be subject to inspection and verification by the Board at any time.
11. It is within the power and functions of U.P. Pollution Control Board to modify/ revoke the terms and conditions of Authorization and issued under the Rule 10 of the Bio-Medical waste Management Rules, 2016.
12. You are hereby directed to comply the stipulated above-mentioned conditions and submit the compliance report and steps taken in this regard within a month so that capacity of the facility may be verified failing which the authorization may be revoked and necessary legal proceeding shall be initiated.
13. You will install ETP to treat the leachate generated during collection/ storage of biomedical waste.
14. The Bio medical waste shall not be disposed of in open place in the premises.
15. Compliance of the sub rules 4(c) and (k) of the biomedical rules should be ensured within 3 months' time & monthly progress report be sent to this office else authorization would be Revoked without further notice.
16. You are hereby directed to comply the provisions of Bio Medical Waste Management Rules, 2016.
17. This authorization shall be valid subject to the validity of agreement with the Common Bio- Medical Waste Treatment facility. Renewed agreement should be submitted before the expiry of existing agreement.
18. You shall maintain records related to the generation, collection, reception storage, Transportation, treatment and disposal and/or any form of handling of Bio-Medical waste in accordance with rules and guidelines, all records shall be subject to inspection and verification by the Board at any time.
19. It is within the power and functions of the U.P. Pollution Control Board to modify/ revoke the terms and conditions of Authorization and issued under Rule 10 of the Bio-Medical waste Management Rules, 2016.
20. The authorized HCF shall obtain consent from the Board also under Air Act, 1981, and Water Act, 1974.
21. This Authorization has been issued on the basis of directions received from Member Secretary, U.P. Pollution Control Board, Lucknow vide letter no.- F. 59439/C-6/Bio-Medical Waste Authorization fees/10, dated 12.01.2010 regarding BMW Authorization fee. Any further order regarding authorization fee from the competent authority shall be applicable to authorized H.C.F.
22. Authorization issued to H.C.F. shall be deemed canceled if H.C.F. loses the membership of Concerned C.B.W.T.F. for any reason.
23. This authorization shall be deemed canceled if the C.B.W.T.F. concerned with authorized HCF has no

valid authorization under BMW Rules and Consent under Air & Water Act.

24. Copy of the agreement deed with CBWTF shall be submitted by authorized H.C.F. within a week after the expiry date of the old agreement deed.

25. The renewal of the MOU with the Combined Bio-Medical Waste Treatment Facility (CBWTF) shall be submitted 15 days from the date of expiry of the membership.

26. Orders issued by Hon'ble NGT New Delhi dated 18.01.2021 in OA no 710 of 2017, OA no 711 of 2017, OA no 712 of 2017, and OA no 713 of 2017 must comply.

27. If UPPCB or CPCB issues a closure order against the HCF, this authorization shall remain suspended for the period till the closure order is revoked, after which the authorization will be effective again for the remaining period.

28. This authorization will not affect the acceptance of directions/orders from any other departments.

29. This authorization is being issued with the intention that no pollution or land ownership dispute is pending, and no such litigation is pending in any court, otherwise, the authorization will be deemed to be nullified.

30. HCF shall ensure to comply The Order passed by Hon'ble NGT in Original Application No. 72/2020 dated 21.04.2020 and the Revised-2 guideline issued by Central Pollution Control Board for Handling, Treatment and Disposal of Waste Generated during Treatment/Diagnosis/ Quarantine of COVID-19 Patients dated 18/04/2020.

31. The Authorization shall comply with provisions of the Environment (Protection) Act 1986 and the rules made there under.

32. You are hereby directed to comply with the stipulated above-mentioned conditions and submit the compliance report and steps taken in this regard within a month so that the capacity of the facility may be verified failing which the authorization may be revoked and necessary legal proceedings shall be initiated. Board reserves its right to amend/cancellation of any of the conditions specified above at any time, in case HCF is found violating any of the conditions of the authorization from time to time. HCF is directed to submit the first compliance report of above mentioned specific and general conditions to the Board within one month.
